NOTICE OF PUBLIC PARTICIPATION FOR THE PREPARATION OF THE BOJANALA PLATINUM DISTRICT MUNICIPALITY SPATIAL DEVELOPMENT FRAMEWORK IN ACCORDANCE WITH THE SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 2013 (ACT NO. 16 OF 2013)

Notice is hereby given that the Bojanala Platinum District Council has resolved at a council meeting held on 31st July 2025 and as per Council Resolution **B01/25/26**, to note and approve the draft Bojanala Platinum District Municipality Spatial Development Framework (SDF) for the commencement of public participation in accordance with Section 20 (3) of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013).

The Spatial Development Framework is described by the Municipal Systems Act 2000 (Act No. 32 of 2000) as an important component of integrated development planning for municipalities. The main objective is to develop a Spatial Development Framework that is in line with the components contemplated in Section 21 of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013).

In this regard, the Bojanala Platinum District Municipality hereby invites comments from interested and affected parties on the draft Spatial Development Framework. Any comments and inputs submitted will be considered during the finalisation of the draft document for final approval and Gazetting.

A copy of the draft Spatial Development Framework and accompanying documents will be available for inspection and comments at the Bojanala Platinum District Municipality offices and all head offices of the local municipalities within the district municipality (Kgetlengrivier, Madibeng, Moretele, Moses Kotane and Rustenburg local municipalities) during normal working hours between 7h30 and 16h00, for 60 days from the 19th of August 2025.
