1. SCOPE OF WORK

The scope of work entails developing / Review the Air Quality Management Plan of District Municipality in line with all the relevant legislation of the Republic of South Africa and in accordance with all relevant policy framework and applicable guidelines.

- 1.1 The role of the Service Providers is to assist BPDM with the project to develop the second generation BPDM AQMP in accordance with the provision of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004).
- 1.2 The appointed service provider will be required to develop:
 - (i) Project Process Plan;
 - (ii) Baseline Assessment (Emission inventory, Source identification, Ambient air monitoring and Dispersion modeling);
 - (iii) Review of the 2011 AQMP;
 - (iv) Intervention Scenarios;
 - (v) Intervention Activities;
 - (vi) Implementation Plan;
 - (vii) Monitoring and Evaluation Tool;
 - (viii) Draft Air Quality Management Plan; (ix) Final Air Quality Management Plan;
 - (x) Capacity building; and
 - (xi) Participation and Efficient and effective intergovernmental coordination and cooperation.

Given the above, the scope of work will include, but is not limited to, conducting research, present the progress of the development of the AQMP at the Authorities/ stakeholders meetings, interviews, workshop facilitation, training courses, management and administrative activities required to generate the required project deliverables.

The scope of this project also includes designing the AQMP for printing, and printing of about 500 and 500 USB putting on the website and other relevant online platform.

2. DELIVERABLES

2.1 The key deliverable envisaged from this project is the District Municipality's Air Quality Management Plan. However, the professional service provider is expected to show creativity by providing details of other supporting deliverables that the project will generate.

The performance measures for the development of Air Quality Management Plan (AQMP) will be closely monitored by BPDM. The Service provider's performance will be measured through the following outputs:

2.2 Outputs

The appointed service provider will carry out all the work required to develop and compile a process plan for the development of the Bojanala Priority Area Air Quality Management Plan and Threat Assessment. This process plan should include, among others:

- a detailed description of how the appointed service provider intends to develop the AQMP in accordance with the project objectives.
- a Gantt Bar Chart detailing the timing and critical path of key activities and milestones.
- a capacity building strategy (National, Provinces and Municipalities).
- proposed plan structure will be based on the appropriate methodology, Objective Oriented Project Planning (OOPP) methodology and/or best practice in the field of air quality management planning.

2.3 Baseline Assessment and Review of 2011 AQMP

Problem analysis

The appointed service provider will carry out all the required meetings, interviews, literature reviews, data collection, data analysis, etc. Revision of the Background report, compilation of the regional Emission Inventory, Ambient air quality assessment chapters, conducting the photochemical modelling, analyze air quality trends since declaration and critic the 2011 implemented against the goals of the AQMP, required to compile the initial Bojanala Air Quality Management Plan and Threat Assessment, namely, the problem analysis. This analysis should review available information in order to generate a chapter that, amongst others:

- Clearly describes the current ambient air quality in the area and compares this to national standards.
- Describes the geographic background of the area (climate, topography, use, etc.).
- Description of meteorology and climate of the area.
- population statistics of the area.
- Identifies significant sources of air pollution in the area.
- Describes the cause-and-effect relationships that give rise to the significant sources of air pollution.
- Clearly describes the overall health, environmental impacts, social and economic impacts of poor air quality in the area.
- Identifies indoor health and other health studies relative to air quality e.g., Municipal Health Service.

- Describes the relative difficulty, or otherwise, of reducing various emissions.
- provides details on any future threats to air quality in the area (new industrial developments, etc.); and (xi) identifies significant information gaps. For clarity, the extensive use of graphics will be required. The problem analysis must also be summarised and illustrated in the form of a "problem tree" that clearly illustrates cause-and-effect relationships.

2.4 Emission Inventory

The appointed service provider will be responsible for, but not limited to, validating the available emission inventories that were developed as part of Bojanala District municipality AQMPs and emission inventory campaign. Furthermore, the service provider will identify any gaps in the existing inventories and where there are gaps, the service provider will collect, collate, and analyze emission inventory data and other required information. The service provider will be required develop a comprehensive database of all identified emission sources such as, but not limited to:

- Industrial operations (point and fugitive emissions)
- Mining activities.
- Domestic fuel burning.
- Vehicle emissions.
- Other fugitive dust sources.
- Chrome Wash plants and Crushing
- Biomass burning; and
- Waste treatment and disposal.

The Service provider will work in close cooperation with the department in the development of the emission inventory and the service provider will be required to hand over all documentation and calculations used in the development of the inventory.

2.5 Dispersion Modelling

Based on the emission inventory developed, the Service Provider will use the appropriate modelling approach to provide air pollution dispersion model results that characterises the impact of air pollution on ambient air quality in both time and space.

The Service provider is expected to describe the modelling approach and demonstrate its applicability. A final decision on the modelling approach should be discussed and approved internally prior to any work commencement and should be in line with the proposed Guideline to Air Dispersion Modeling for Air Quality Management in South Africa, published on the 14 December 2012 (Gazette No. 35981). Upon completion of the project the service provider will supply the Department with copies of all input data, model parameterization and post-

processing files, to be installed and operational on the Department's dispersion modelling computer.

2.6 Baseline Assessment Report Compilation

The Service provider will be required to compile a baseline report that describes the current air quality status in the priority Area, with the view of developing strategies and interventions. The baseline report should include an assessment of existing emissions from various sources in the area, ambient air quality data from various monitoring stations in the priority area in relation to ambient air quality standards, the results of the dispersion modeling and other collected information. This is the most important document that will provide the statusquo of air quality in the WBPA and therefore direct interventions. The Baseline Assessment will be work-shopped internally and to the ITT workshop for endorsement prior to publication. In general, the baseline report will include:

- All findings of problem analysis (output 2A)
- Estimated emissions from various sources and a description of the contributions of various sources of pollution to the ambient air quality in the area (output 2B)
- Results of the dispersion modelling exercise indicating the potential impacts of missions to ambient air quality (output 2C)
- A description of current challenges of reducing various emissions; and
- Any identified information gaps.

2.7 Threat Assessment and Scenario Building

The appointed service provider will undertake a further inventory of future sources of emissions in the WBPA based on the Integrated Development Plan (IDP) with the aim of establishing potential air quality threats in the priority area. To achieve this, the service provider will collect, collate and analyse all the available information on the future infrastructure projects that have been proposed in the WBPA and based on that estimate possible emissions that are likely to results from all activities associated with such projects. These will include, but not limited to:

- Planned industrial activities
- Planned mining activities
- Emissions from domestic fuel burning; and
- Other planned projects with air quality impacts.

However, the Service provider will group/categorise projects in terms of their specified implementation timeframes. This categorization will assist in developing various scenarios.

Threat Assessment Scenario Development and Modelling

Based on the findings of threat assessment emissions inventory and the potential future emissions; cumulative air quality impacts associated with specific future infrastructure and other developments in the WBPA will be estimated using the same model used to generate output 2.C.

Various time-based scenarios will be modeled based on the projected

implementation timeframes of various infrastructure/developmental projects. At this stage it is envisaged that 4 scenarios will be developed and modeled (2020, 2030, 2040 and 2050) but the final decision on the modeled scenarios will be made by the project.

Governance Capacity Development

The service provider must aim to contribute to the development of the necessary air quality management and planning capacity within government National, Provincial and Municipal Capacity Building. Working in close cooperation with Government officials relevant for implementation of the BPDM AQMP, the appointed service provider must generate a capacity development plan. 1.2	"Contract"	means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price"	means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice"	means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties"	are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin"	means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
1.7	"Day"	means calendar day.
1.8	"Delivery"	means delivery in compliance of the conditions of the contract or order
1.9	"Delivery ex stock"	means immediate delivery directly from stock actually on hand
1.10	"Delivery into consignees store or to his site"	means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping"	occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure"	means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice"	means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to

		deprive the bidder of the benefits of free and open competition.
1.14	“GCC”	means the General Conditions of Contract for Constructions Works, Third edition, 2015 (GCC 2015).
1.15	“Goods”	means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	“Imported content”	means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be Page 19 of 47 imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	“Local content”	means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
1.18	“Manufacture”	means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
1.19	“Order”	means an official written order issued for the supply of goods or works or the rendering of a service.
1.20	“Project site”	where applicable, means the place indicated in bidding documents.
1.21	“Purchaser”	means the organization purchasing the goods.
1.22	“Republic”	means the Republic of South Africa.
1.23	“SCC”	means the Special Conditions of Contract.
1.24	“Services”	means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	“Supplier”	means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
1.26	“Tort”	means in breach of contract.
1.27	“Turnkey”	means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
1.28	“Written” or “in writing”	means handwritten in ink or any form of electronic or mechanical writing.

2. APPLICATION	
1.1	These general conditions are applicable to all tenders, contracts and orders including tenders for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the tendering documents.
1.2	Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
1.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
2. GENERAL	
2.1	Unless otherwise indicated in the tendering documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a tender. Where applicable a non-refundable fee for documents may be charged.
2.2	Invitations to tender are usually published in locally distributed news media and on the Municipality /municipal entity website.
3. STANDARDS	
3.1	The goods supplied shall conform to the standards mentioned in the tendering documents and specifications.
4. USE OF CONTRACT DOCUMENTS AND INFORMATION INSPECTION	
4.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
4.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
4.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
4.4	The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
5. PATENT RIGHTS	
5.1	The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
5.2	When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

6. PERFORMANCE SECURITY

6.1	Within thirty (30) days of receipt of the notification of contract award, the successful tenderer shall furnish to the purchaser the performance security of the amount specified in SCC.
6.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract
6.3	The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms: a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the tendering documents or another form acceptable to the purchaser; or b) a cashier's or certified Cheque.
6.4	The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

7. INSPECTION, TESTS AND ANALYSES

7.1	All pre-tendering testing will be for the account of the tenderer.
7.2	If it is a tender condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the tenderer or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.
7.3	If there are no inspection requirements indicated in the tendering documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
7.4	If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
7.5	Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
7.6	Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
7.7	Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal, the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

7.8	The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

8. PACKING

8.1	The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. 12.2	Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

13. SPARE PARTS

13.1	14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by

14. WARRANTY

14.1	The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
14.2	This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
14.3	The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
14.4	Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
14.5	If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

15. PAYMENT

15.1	The method and conditions of payment to be made to the supplier under this contract shall be specified.
15.2	The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
15.3	Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
15.4	Payment will be made in Rand unless otherwise stipulated.

16. PRICES

16.1	Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his tender, with the exception of any price adjustments authorized or in the purchaser's request for tender validity extension, as the case may be.

17. VARIATION ORDERS

17.1	In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

18. ASSIGNMENT

18.1	The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

19. SUBCONTRACTORS

19.1	The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the tender. Such notification, in the original tender or later, shall not relieve the supplier from any liability or obligation under the contract.

20. DELAYS IN THE SUPPLIER'S PERFORMANCE

20.1	Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

20.2	If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

20.3	The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

20.4	Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

20.5	Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

21. PENALTIES

21.1	Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

22. TERMINATION FOR DEFAULT

22.2	In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23. ANTIDUMPING AND COUNTERVAILING DUTIES AND RIGHTS

23.1	When, after the date of tender, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favorable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

24. FORCE MAJEURE

24.1	Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
24.2	If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

25. TERMINATION FOR INSOLVENCY

25.1	The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

26. SETTLEMENT OF DISPUTES

26.1	If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.1	Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
27.2	<p>Notwithstanding any reference to mediation and/or court proceedings herein,</p> <ul style="list-style-type: none"> a) The parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and b) The purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.
27.3	<p>Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;</p> <ul style="list-style-type: none"> a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and b) The aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

28. GOVERNING LANGUAGE

28.1	The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

29. APPLICABLE LAW

29.1	The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

30. NOTICES

30.1	Every written acceptance of a tender shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his tender or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.

30.2	The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

31. TAXES AND DUTIES

31.1	A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

31.3	No contract shall be concluded with any tenderer whose tax matters are not in order. Prior to the award of a tender SARS must have certified that the tax matters of the preferred tenderer are in order.

31.4	No contract shall be concluded with any tenderer whose municipal rates and taxes and municipal services charges are in arrears.

32. TRANSFER OF CONTRACTS

32.1	The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser

33. AMENDMENT OF CONTRACTS

33.1	No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

IMPORTANT NOTICE TO ALL BIDDERS / TENDERERS

No tender will be considered if correctional fluid (Tipp-Ex) was used. Corrections shall be done as follows:

Scratch out the error, rewrite it and sign next to the corrected price.

Tenderers are requested to draw a diagonal line in the space provided for prices on which they do not tender on. This is to ensure that no prices are inserted after closing date. All items to be priced.

Tenderers will be disqualified should they submit more than one tender document per company indicating different prices for the same tender.

Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contracts
