1. SCOPE OF WORK

1. PROJECT SCOPE

BPDM requires the Service Provider to be able to provide travel management services locally and nationally. The appointed Service Provider will be required to arrange travel and accommodation on request by BPDM.

4.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
4.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
